Notice is also hereby given pursuant to Section 91 of the Act and Regulation 42 of the SEBI Listing Regulations, 2015 that the Register of Members and Share Transfer Books of the Company will remain closed from **Wednesday, 21<sup>st</sup> July, 2021 to Tuesday, 27<sup>th</sup> July, 2021 (both days inclusive)** for the purpose of payment of Dividend and Annual General Meeting of the Company for the F.Y. 2020-21.

The Company is pleased to provide its members the facility of casting votes electronically ("remote e-voting"), through the e-voting services provided by National Securities Depository Limited ("NSDL").

The remote e-voting period begins on **24<sup>th</sup> July, 2021 at 9:00 a.m. IST** and ends on **26<sup>th</sup> July, 2021 at 5:00 p.m. IST**. During this period, members of the Company, holding shares as at the cut-off date of **20<sup>th</sup> July, 2021** may cast their vote electronically. The remote e-voting module shall be disabled by NSDL thereafter. Members have the option to cast their vote on any of the resolutions using the remote e-voting facility either during the aforesaid voting period or during the AGM.

The members who have casted their vote by remote e-voting prior to the AGM may also attend / participate in the AGM through VC / OAVM, but shall not be entitled to cast their vote again. The detailed procedure for remote e-voting and e-voting during the AGM is provided in the Notice of AGM.

Any person holding shares in physical form and non-individual shareholders, who acquires shares of the Company and becomes member of the Company after sending of the Notice and holding shares as on the cut-off date, may obtain the login Id and password by sending request at [evoting@nsdl.co.in](mailto:evoting@nsdl.co.in). However, if he / she is already registered with NSDL for remote e-voting then he /she can use his / her existing User ID and password for casting the vote.
